2. Human Resources and Risk Management

- **First draft of Election Ordinance presented to council. Towanna Dixon from the Board of Elections will be meeting with council to discuss changes to election process.**

Public Works and Utilities:

1. Compliance Letters

- **Discussing the criteria for compliance letters; cutting down trees, building, electrical work—if it requires an inspection then it will be sent to Moore County. Compliance letters are not new.**
- **Next printing of water bills will include information about compliance letter.**

2. Bernie Schaub Request for Water and Sewer

Requesting water and sewer for property across from Pinesage. He is requesting for commercial water and sewer—this property is not in Taylortown, but in Moore County. We do not know at this moment how this would affect the sensitive water pressure in Pinesage. Council would like more information on the matter before

considering it any further—Mr. Schaub will be invited to come before council to further discuss it.
