BUDGET ORDINANCE and Technical Correction Amendment FY 2025-2026

WHEREAS, the Town Council, in accordance with the laws of the state of North Carolina, oversees the preparation and adoption of the budget for the Town of Taylortown;

WHEREAS, the Town Council published in The Pilot Newspaper, a legal notice of public hearing to be held on May 27, 2025 at 6:00 p.m. at the Town Hall in Taylortown, North Carolina for public input into the town's FY 2025-26 budget and did hold such hearing on said date;

WHEREAS, the Town Council heretofore established departments for the operation of the town government and presents its budget by departments for a total amount of \$1,182,282 and a Water Fund budget in the amount of \$231,806;

WHEREAS, the Town Council authorizes the Finance Officer, Deputy Finance Officer, Town Manager, and Finance Director to reallocate funds between departments when necessary for the efficient operation of departments;

WHEREAS, the Town Council shall require a budget amendment if and when any reallocation of funds between departments causes the town to exceed the total operating budget for FY 2025-26;

WHEREAS, the Town Council makes the following technical corrections:

- 1. The budget was originally adopted on June 24, 2025. The clerical error states June 10, 2025. On the same page, the heading correctly reads June 24, 2025 (See attached budget adoption schedule.)
- 2. All amounts in the budget have been rounded to the nearest whole number.

- 3. The Water and Sewer debt service was changed to \$31,088.
- **4.** The Powell Bill revenue of \$22,000 is reflected in the budget expenditures in the amount of \$22,000 for streets and roads.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF TAYLORTOWN, NORTH CAROLINA, the following amounts are hereby appropriated in the General Fund and the Water Fund with the technical corrections for the operation of the town government and its water and sewer operation for the fiscal year beginning July 1, 2025 and ending June 30, 2026.
